Terms and Conditions Policy for Event Cakes and Refunds

1. **Deposits:** When you reserve an event date there is a \$300.00 deposit required. This deposit holds your date and time slot. Payment is due in full 14 business days prior to your event date. Any payments received during that 14 day window must be cash or credit card. **No checks** accepted beyond 14 business days. By giving a phone deposit you agree to Farmington Bakery's terms and conditions policy.
2. **Quotes:** We reserve the rights to adjust quotes due to human mathematical error, price increases, or expired quotes.
3. **Plastics:** There is a \$7.00 per separation plastics charge. This charge is fully refundable only when all pieces are returned intact and fully cleaned or fee is forfeited.
4. **Stand Rental:** All Stands and kits must be returned within 5 days following event, clean, intact and in proper working order.
 - a. **Small Stands:** \$30.00 Refundable Deposit Required, \$15.00 Non-Refundable rental fee.
 - b. **Large Stands and Fountain Kits:** \$100.00 Refundable Deposit Required, \$30.00 Non-Refundable rental fee.
5. **Cake Orders:** By purchasing a cake from Farmington Bakery you are expected to purchase all cakes, including sheet cakes, from us. For liability purposes we cannot have someone else's product being falsely represented as our product without knowledge or written consent. If you violate this policy we reserve the right to revoke our cake at any time with NO REFUND given.
6. **Outside Accessories:** Farmington Bakery provides the cake only. Cake services such as accents or accessories are not furnished by Farmington Bakery including but not limited to: ribbons, floral, or ornamentations. Outside accessories not furnished by Farmington Bakery need to be cleaned, cut, trimmed, etc. before they are brought in for placement. Please open package and inspect your

purchase. Label all items with event name and date. If specifics are required, please include placement instructions or a diagram. If there are no instructions, item will be placed at Farmington Bakery's discretion.

7. **Color Matching:** Farmington Bakery is not responsible for exact color matching or darkening of frosting due to Time, Temperature, or Humidity. (Note: Ribbon will darken, frosting will darken over time.) *Ribbon applied to cake may bow until cake comes to room temperature due to contraction of chilled frosting.
8. **Pick Up & Delivery Policy:** We are not responsible for anything damaged after pick up. There will be additional fees for delivery. A non-confirmative site fee will be added for Special Sets, After Hours, Delivery, Large Complex, Large Event Site, Boat Site, Holiday's, Sunday and Monday.
9. **Farmington Bakery is not responsible for:** Taste changes due to addition of color or recipe changes additions or subtraction of different sources such as: color, ornamentals, flowers fresh or silk, ribbon, papers, toppers, bows or any other items added to the interior or exterior of the product. Slight Imperfections in design quality due to normal frosting functions: air, humidity, color lightening or darkening, 100% smoothness not guaranteed.
10. **Rescheduling:** If event date needs to be rescheduled, all deposits would be held and transferred to new event date unless product process has begun. The product cost will be forfeited and a new contract will need to be initiated.
11. **Cancellation:** \$100.00 of the deposit is Non-refundable for administrative costs up to 14 days prior to the event date. Cancellation between day 14 and day 7 is an additional \$50.00 Non-refundable professional service fee. Cancellation during the week of the event means the entire \$300.00 deposit is forfeited, unless the product process has started, entire cost of product is forfeited. This will be at Farmington Bakery discretion as to which fees, if any, will be refunded during the production process.
12. **Refunds:** Refunds will be issued by check in 7-10 business days to the name and address provided on the contract.
13. **Topper:** 1st year anniversary topper is included in the original wedding cake (to be used as you wish after wedding date.) This cake is not included in the original wedding cake price; it is the Farmington Bakery's gift to you.
